MCPF will be partially re-open from Feb. 25, 2020 (Tue). In accordance with the University's guidelines, users are required to fill in a Health Declaration Form before entering laboratories. Therefore, if you plan to use MCPF laboratories, please fill in the "MCPF Health Declaration Form" as soon as possible using one of the two methods below:

- 2) fill in the attached form (MCPF Health Declaration Form.pdf) and return it to MCPF by email (mcpf@ust.hk) or send the hardcopy to MCPF admin office (Room 2575).

Your submission must be entered into the MCPF records, before you are allowed to enter MCPF laboratories. Please also note that you need to bring your own surgical mask, lab coat and gloves when working in MCPF labs.

Special procedure for booking of equipment during this period of partial operation will be announced later.

## **MCPF Health Declaration Form**

It is the University's policy that if someone returns from overseas (irrespective of countries and territories, but not including Macao SAR and Taiwan), that person must self-quarantine at home/quarters for 14-days. Any person under self-quarantine is prohibited to access MCPF laboratories.
